# **Presentation material**

During the meeting a ppt presentation was used following the agenda that was sent out prior to the meeting. This ppt presentation will be archived on the SIREUS website alongside the minutes.

### Minutes

1.

- a. Christer opened the meeting and welcomed everyone.
- b. The minutes from the previous meeting were reviewed.
- c. Christer updated the group about what's been going on with SIREUS since the last meeting. The SIREUS VIRTUAL forum is starting to take shape and we need to have a Program Borad of 3-4 members that can help with topics. Christer then mentioned about the possible Innovation trip to Texas that is now scheduled to be during February 5<sup>th</sup> -9<sup>th</sup> 2024 a planning group is formed, but we need more members to the group. They are also working on planning for the SIREUS ENTREPRENEURS forum in Denver in conjunction with Destination Start-Up, now to be held March 21<sup>st</sup> 22<sup>nd</sup> ,2024. Christer further mentioned that SIREUS is in the final planning stage for a larger Study in Sweden trip within working Group 4 that will start in New York, and continue to Washington State University, Pullman, and Chapman University in California. Last meeting, we mentioned that SIREUS is planning a soft launch SIREUS Affiliation of Companies. This is now in full swing and Ericsson, AstraZeneca, SAAB, Volvo and Einride are engaged in the dialogue.

Christer further informed the group that he had an intensive visit to Stockholm a couple of weeks ago. He "promoted" SIREUS and met KK, STINT, VR, IVA, UHR, SI, UD, KMH, AmCham and Einride. They all articulated that they are very impressed with our achievement so far and is willing to support the program in any way they can. He also mentioned that he is researching

the possibility of having the SIREUS CHANCELLORS forum in Stockholm during the spring. The original plan for March  $20^{th} - 21^{st}$ , 2024 @ MDU will not work for different reasons.

- 2. Christer further reminded the group to review SIREUS five chosen thematic areas on the website. He showed a summary of which links SIREUS has received from each university and reminded those who have not sent in their links to do so. The universities can submit their links connected to each Thematic Area to show their expertise within those specific fields. The plan is that after each Swedish university has submitted relevant links, the American Affiliated universities will do the same. This will help faculty and researchers from universities in both Sweden and the U.S. find areas of collaboration.
- 3. Christer asked the group if they had any specific areas of interest in the U.S. where they want to recruit students from or promote internships with. This could include what type of universities or which type of companies they would like to connect with. Stefan said that since most participants in the meeting handle student recruitment, all American students are interesting and that there are no prioritized areas of the U.S. that they're looking to recruit from. Christer then asked the group if the rest of the group felt the same way and they did.

Jenny then joined the meeting and updated the group on the status with FAFSA. She has been in contact with Lund University and requested a more specific summary of which universities are affected. Maria said that she had asked this question in an international forum where she has seen that other institutions for higher education also could be affected by similar issues. She further highlighted that it varies a lot for the universities since this hasn't affected everyone at the same time.

Jenny said that they are discussing this with the Swedish government and the U.S. Department of Education. She said that she will continue to investigate the matter. The group agreed that the universities need to unite in this issue and raise the question in joint forums.

Christer introduced a question regarding what areas the universities think / know their exchange students from the US for the spring semester 2024 is from. The Swedish Embassy has raised the question in conjunction with where the best place for "pop-up booths" for the VISA process would be. **[Each member responds to Edith and Christer for a quick answer].** 

4. Edith and Oskar presented the Study in Sweden tour that will take place between November 2<sup>nd</sup> -6<sup>th</sup>. Oskar introduced himself to the group as the SIREUS Event Intern and announced that he will be joining the group on the trip to help with the practical details. He explained that the tour will begin in New York on November 2<sup>nd</sup> between 4-8PM where a Study in Sweden fair will be held at the Swedish-American Chamber of Commerce in New York on 900 3rd Avenue. The event will also feature catering, speakers and alumni. The group discussed if it would be possible to gain more participants at the fair by splitting the time slots since the location only allows 80 people. It was decided that there will be three types of tickets for the event: one for the 4-5:30 PM time, one for the 5:30-7PM time slot and one for the

speakers panel between 7-8 PM. This allows the universities to meet with more participants.

Next the plan for the Study in Sweden event at Washington State University in Pullman was discussed. The event will take place at the Smith Center for Undergraduate Education on campus between 11 AM and 2 PM and will be carried out as a classic Study in Sweden tabletop fair. Christer mentioned that it would be interesting to have a speakers panel at this stop as well, possibly with alumni if there are any present in that area. The event will take place on a game day against Stanford and Christer encouraged everyone in the group to fill out the joint planning document with information if they want to attend a football game. Christer also brought up the issue of transportation from Spokane to Pullman and explained that renting a bus would be very expensive, therefore suggesting that renting cars or getting taxis could be other options. He stated that he will get in touch with Paul at WSU about reserving taxis.

The tour ends at Chapman University in Orange, CA where a study in Sweden event is planned on campus. Oskar explained that SIREUS has reserved the main Piazza on campus where the universities will be able to meet students between 11 AM to 1:30 PM. After this, there will be a speaker's panel held at AF209 between 2:30 PM-4PM where students can learn more about Sweden as a destination for higher studies. The event will also feature catered food and snacks.

Edith presented the overall marketing strategy for the tour, highlighting that SIREUS will reach out to our regional chambers in the areas for additional support. She explained that they are in contact with the Centers for Global Education at both Chapman and WSU who will share this information to students at the respective universities through their Social Media platforms and newsletters. Furthermore, SIREUS will post three Ad campaigns on Instagram containing the Eventbrite link for each event. The three posts will be targeted at young people in each geographic area that are interested in Sweden and pursuing a degree abroad. She also showed the graphic material for the campaigns as well as the "Save the Date" texts for Eventbrite.

She further explained that as soon as the events are published on Eventbrite, she needs the group to **send out the events to their alumni and prospective students in each area**. Christer reminded everyone to fill out their travel information in the **shared planning document** to facilitate the coordination on-site.

It was mentioned during the meeting that SI will hold a Virtual Study in Sweden event on October 14th between 15:00 – 19:00 CET.
